Dr Ronald de Bruin **Director of the COST Association**

Dr Ronald de Bruin was appointed Director of the COST Association on 1 June 2016. Before joining the Association, Ronald was Director of the European Institute of Innovation and Technology (EIT) and Head of Department of the European Network and Information Security Agency (ENISA). Prior to this, he was Deputy Director of a public-private partnership platform for the Information Society in the Netherlands for over three years. He started his career as Policy Advisor for the Dutch national government, where, for three years, he was responsible for developing a national policy on e-security services, and scenarios for introducing digital TV.

He is Ambassador to Brussels for the Greenleaf Center for Servant Leadership Europe and Founding Director of the Greenleaf Center in Brussels. Dr De Bruin has also authored several books on servant-leadership, digital television, online consumer trust and computer security. He holds a Ph.D. in Law and Computer Science, an M.Sc. in Technology Management and a B.Sc. in Electronic Engineering.

Dr Deniz Karaca

She acts as a **Science Officer at COST Association**. After gaining extensive experience in coordination and implementation of European and international science and technology development programmes through her previous position as Science Project Coordinator, Deniz joined COST Association in 2013. She has expanded her knowledge of science policy, project management and evaluation systems at her current post.

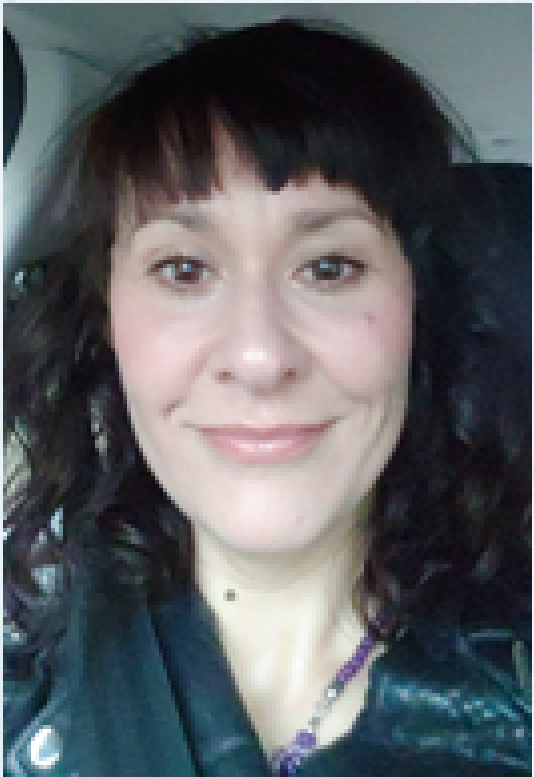

Jadwiga Mrozowska

She is the **COST National Coordinator at the Ministry of Education and Science** (since September 2016) and acts as a member of COST Committee of Senior Officials (CSO). In the Ministry of Education and Science Ms. Mrozowska is also responsible for bilateral cooperation with India, Middle East and North African countries.

She has 14 years' experience in international cooperation. In 2004 she graduated in sociology in Collegium Civitas and in 2008 she completed post-graduate studies in the field of sociology organized by the Institute of Political Studies of the Polish Academy of Sciences in cooperation with Collegium Civitas.



Prof. Danuta Kruk

Between 2016 and 2021 she acted as an action chair of the international COST action entitled **European Network on NMR Relaxometry**.

She is professor of physics at the University of Warmia and Mazury in Olsztyn, author of about 150 publications, interested in e.g. theory of spin resonances and relaxation processes and dynamics of viscous liquids and glass-forming systems. Prof. Kruk is also a finalist of Innovation Radar Prize: Excellent Science, 2017, for a concept of a novel contrast mechanism for Magnetic Resonance Imaging. She spent several years abroad: Stockholm University, Darmstadt Technical University, Bayreuth University. Prof. Kruk is also the author of two books: Kruk D. (2007) Theory of Evolution and Relaxation of Multi-spin Systems. Application to Nuclear Magnetic Resonance (NMR) and Electron Spin Resonance (ESR), Arima, Bury St Edmunds UK; Kruk D. (2015) Understanding Spin Dynamics, Pan Stanford.

Dr Tomasz Bochenek

In years 2018-2021 he was involved in the research network COST Action: **European Medicines Shortages Research Network (Medicines Shortages)**, as the Management Committee Member, Working Group Leader and then the Chair of the Action.

He is the Deputy Director of the Institute of Public Health at the Jagiellonian University Medical College in Krakow, Poland, and the Assistant Professor at the Department of Drug Management therein. His professional interests include public health, pharmaceutical policy, pricing and reimbursement of medicines and medical devices, as well as utilization of health technology assessment for funding health care services. He also worked as the expert for the Minister of Health, the Agency for Health Technology Assessment and Tariff System, and other organizations in Poland and abroad.



Dr Piotr Wciślik

He is the Grand Holder's Scientific Representative of the COST Action **New Exploratory Phase in Research on East European Cultures of Dissent** (nep4dissent.eu).

Dr Wciślik is assistant professor and deputy director at the Digital Humanities Center of the Institute of Literary Research of the Polish Academy of Sciences (IBL PAN). Piotr's most recent book is *Dissident Legacies of Samizdat Social Media Activism: Unlicensed Print Culture in Poland 1976-1990* (Routledge 2021). His latest work combines intellectual history of dissent and bibliographic data-driven methods in digital humanities.
