**Polish version of the UNGEGN brochure and resolutions adopted at the United Nations Conferences on the Standardization of Geographical Names, and English version of regulations concerning the standardization of geographical names in Poland**

To better promote the important work of the UNGEGN in Poland the Commission on Standardization of Geographical Names Outside the Republic of Poland prepared a version of the UNGEGN brochure *Consistent Use of Place Names* in Polish. Layout and content of the original version, existing in the six official UN languages, have been retained. Polish version of the UNGEGN brochure was published in 2009.

UNGEGN brochure was officially presented locally and distributed to the Government and to semi-governmental services, to publishers of geographic and cartographic publication as well as textbooks and encyclopedias. This brochure was also attached to Toponymic publications of Commission on Standardization of Geographical Names Outside the Republic of Poland.
