Original – it means that the document should be signed with an electronic qualified signature (as defined in regulation EU No 910/2014 on electronic identification and trust services for electronic transactions in the internal market and repealing Directive 1999/93/EC) or trusted signature (signature related to the platform ePUAP), or handwritten signature. If a document in eCTD is a copy of the document signed with a handwritten signature, the marketing authorisation holder should additionally submit the paper document signed with an original handwritten signature.

Original / Copy – it means that the submission of a copy of the signed document is sufficient or a signature is not required.

PL – it means that the document should be prepared in Polish or translated into Polish. If the document was prepared in a language other than Polish, its translation into Polish must be attached to the document. The translation must be certified by a sworn translator.

Documents can be submitted in paper or electronic form via ePUAP or CESP. Submitting documents in any other way (e.g. via Eudralink, email) is not acceptable.
