SUBJECT: Notification of Intent to Issue an Invitation for International Bidding (IFIB) for Contract Support to Joint Warfare Centre (JWC) for Short Term Operational Contractors (STOC) at JWC, Stavanger, Norway.

1. In accordance with the stipulations of the Bi-SC Procurement Directive 60-70, Annex B, the following information is provided on an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release:

Title of IFIB: Exercise Support - Short Term Operational Contractors (STOC)

Requirement: JWC is seeking contract support to continue the provision of exercise delivery with Short Term Operational Contractors for specific exercise events. Subject matter experts will be needed to fill multiple Exercise Play Functions (EPFs) as role players in the Exercise Control Organization (EXCON). Each exercise will have a unique combination of EPFs and thus, set of STOCs depending on the scenario and exercise design. For this requirement, the Bidding Company's personnel will be required (before award of this contract) to have a NATO SECRET security clearance or national level equivalent.
