REGULATION OF THE NATIONAL BROADCASTING COUNCIL

of 21 October 2021

concerning the template of the list of on-demand audiovisual media services and the template of the notification for registration in the said list.

Under Article 47ca paragraph 6 of the Broadcasting Act of 29 December 1992 (official journal "Dz.U." of 2020, item 805 and of 2021, item 1676), this Regulation is hereby enacted.

- § 2 The template of the notification for registration in the list of on-demand audiovisual media services is attached as the Appendix No. 2 hereto.
 - § 3 This Regulation shall come into force on 1 November 2021.

Purposes and Basis for Data Processing

We will be processing your personal data provided in this form for the purpose of keeping the list of the on-demand audiovisual media services referred to in Article 47n paragraph 1 of the Broadcasting Act of 29 December 1992, and subsequently for the purpose of fulfilling the obligation to archive documents pursuant to the Act of 14 July 1983 on the National Archive Resources and Archives. Article 6(1)(c) of the GDPR is the legal basis for the processing of your data.⁵

Data Retention Period

We will retain your personal data contained in the form until the date on which the service is removed from the list and thereafter, in accordance with the uniform list of files and document archiving regulations applicable in the Office of the National Broadcasting Council for a period of 10 years from the end of the year in which the service was removed from the list.

Rights of Data Subjects

According to the GDPR, you have the following rights:

- a) the right to access your data and receive a copy of the data,
- b) the right to rectify (correct) your data,
- c) the right to request the processing of the data to be limited,
- d) the right to lodge a complaint to the President of the Office for Personal Data Protection (UODO) (to the address of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warszawa).
