RENEWAL OF RADOME AT YAMADAĞ RADAR SITE

Reference : AC/4-D/2261(1996 Edition), 12 January 1996

1. The Ministry of National Defense of Turkey (MOD-TUR) intends, in accordance with paragraph 6 of reference, to invite bids for the project "Renewal of Radome at Yamadağ Radar Site".
2. An overview of the requirements for this IFB is to procure/install a radome for RAT-31 DL radar located at 219th Air Radar Command Yamadağ/Malatya.
3. The estimated value for this project is 949.249,00 Euro. You will be expected not to disclose budget information to prospective bidders. The estimated time of completion of the Project is 300 (three hundred) calendar days from the contract signature date.
4. MOD-TUR intends to use the NCB+ Procedure. Contractor selection will be based on the lowest compliant bid. The IFB is planned to be released in June 2019 with a Bid Closing Date in July 2019. Bids will be valid for 01 January 2020 and contract will be awarded by the end of July 2019.
5. The justification paper regarding the fact that the company to be determined eligible for this Competitive Bidding either has completed or is executing a similar Project or is capable of doing "Procurement and Installation of Radome or Fixed Position Radar" shall be submitted by the bidder company's Nation.
6. It is requested that MOD-TUR will be provided, not later than 15 June 2019 (latest 11:00 hours) with a list of firms, who are interested in receiving IFB for this project. The bidders list should include Name of the Firm, Telephone and Fax Number, e-mail address and Point-of-Contact (POC) for each firm. This information is essential to enable prompt and accurate communication with prospective bidders and should be sent to the following address:

It is requested that all firms interested in participating in this procurement be introduced by their National Delegations to NATO or Embassies in Ankara through Ministry of Foreign Affairs/Turkey with the required "Declaration of Eligibility" document which will contain the full statutory name and address of those firms. Application for participation directly from the firms shall not be considered.
