Information on the processing of personal data in consular files

- 3. The Minister of Foreign Affairs has appointed a Data Protection Officer (DPO) who performs his duties in relation to data processed in the Ministry of Foreign Affairs and foreign missions. This function is performed by Mr. Daniel Szczęsny.

- 4. Only persons authorized by the Administrator have access to the data.
- 5. The data contained in the consular files are processed on the basis of the premises contained in Article 6(1)(c) of the GDPR in order for the consul of the Republic of Poland to fulfil its obligations under separate provisions of law (indicated in the table below).
- 6. The data is protected under the provisions of the GDPR and may not be made available to third parties who are not authorized to access this data, and will not be transferred to a third country that does not meet the guarantee of protection at least equivalent to that provided for in the provisions of the GDPR. The data may be transferred to a third country only if such an obligation is specified in the Polish law or the law of the European Union, in accordance with the provisions of Articles 44 46 of the GDPR.
- 7. Your data may be made available to relevant entities, including public authorities, on the basis of legal provisions.
- 8. Providing your personal data is a statutory requirement and is necessary for the consideration of the case.
- 9. Unless specific provisions provide otherwise, you have the rights to control the processing of your data, as set out in Articles 15-19 of the GDPR, in particular the right to access your data and to rectify, delete or limit processing (if Articles 17 and 18 of the GDPR apply).
- 10. Your data will not be processed in an automated manner that will affect the decision-making process that may have legal effects or significantly affect it in a similar way. The data will not be subject to profiling.
