1. In the event of any questions concerning technique and scope of personal data processing, as well as warranty prerogatives, please contact local Superintendent for personal data protection via email: inspektorochronydanych@kowalczyk.pro.
2. Your personal data are collected and processed only for executional reasons for 2nd International Piano Duets Contest.
3. Your personal data are to be processed based on Contest's Statute and based on Minister of Culture and National Heritage's Act on competitions, tournaments, contests organizing and performing for public and artistic schools dated November 21st 2019.
4. Recipients to your personal data may only be subjects or entities authorized to receive any personal data statued by Artistic Educational Center in Warsaw.
5. Your personal data are to be held for minimum period of 5 years according to Unified Factual List of Acts and later on only for promotional reasons.
6. As processing your personal data you hold the list of the following prerogatives:
 - the right to Access to one's own personal data, in this case, the right to receive a copy of any kind of those;
 - the right to your personal data correction, in this case, when your personal data prove to be incorrect or incomplete;
 - in justified cases the right to deleting your personal data and limiting it's processing;
 - in case when your personal data processing undergoes based on your approval, you hold the right to cancel this approval anytime, with no actual impact on its processing accuracy before being cancelled.
7. Submitting your personal data is obligatory due to Contest's Statute applying.
8. You reserve the right to file a complaint to a supervising institution which is Chairman of the Personal Data Protection Office, whenever you find that your personal data processing, considering yourself, violates general laws of General Act of Personal Data Protection datek 27th April 2016.
