4407	Nagged timber or planed along, split or shelled, hewn or undressed, polished or not polished, connected or not connected to spine, over 6 mm thick
4408	Letters veneer and veneer, sheets for plywood (glued or pasted) and other types of wood, nagged lengthways, cut into parts or Rotary, planed or not planed, with polished or polished surface, connected or not connected to spine thickness not exceeding 6 mm
4409	Wood & Timber (including non-assembled parquet planks and strips) in the form of profiled planed timber (with ridges, grooves, matched with oblique edges, connecting in a half-round kalovky, shaped, rounded and so on) along any edges or planes planed or planed, ground or polished, connected or not connected to spine
4415**	Boxes, packing baskets, drums and similar containers made of wood, wooden drums (reels) for cables, trays, pallets of boards and other wooden loading boards; wooden board for pallets
4418	Joinery and carpentry construction details, including porous wood panels, shingle and shakes, roofing (except prefabricated parquet slabs)
