# The main elements of existing/planned governance structure

# Key mechanisms ensuring cross-sectoral (horizontal) coordination



- MEiN has its own delegates to Horizon Europe Programme Committee (PC HE) and regular contacts with delegates to Missions Working subgroups under the Strategic Configuration of the PC HE, Mission NCPs, ERA Forum (ERA Action 10: Make EU Missions and partnerships key contributors to ERA), through National Centre for Research and Development Office in Brussels with TRAMI
- Sectoral ministries are involved in the relevant missions
- Stakeholders propose the creation of an inter-ministerial working groups, the working groups should be coordinated by the sectoral ministries (or adding the mission topic to existing groups e.g. the Executive Council of the National Urban Policy 2030)



# Mechanism ensuring vertical coordination between national/regional/local levels



Mission Hubs :

- Key stakeholders already involved in mission activities will establish mission hubs.
- The hub's task will be to build a network of collaboration between national, regional and local levels and map potential synergies.
- Mission hubs will report to the inter-ministerial working groups challenges that should be solved at the governmental level (mainly concerns legal changes and financing).

# Different approaches for the different missions



EU Missions are implemented case-by-case within the respective national policies and/ or initiatives.

We plan to establish hubs for 4 missions. In the case of the Water Mission, we are not planning to create a hub. We remain in contact with key stakeholders and may change our approach when appropriate potential arises.



# Challenges for the implementation of EU missions



- Limited resources at Ministry/Institution level (both skills and staff, as well as financial resources)
- Visibility of the EU missions among national stakeholders and/or policymakers
- Ensuring the flow of information and communication
- Encouraging more Polish entities to participate in EU missions
- Overlapping of topics within different HE pillars, which may be confusing for stakeholders (WP 6 clusters, partnerships, missions etc.)
