Joaquim Barbosa – PPCC / EDP Renewables Polska

Economist/ MBA. 15 years of experience in Energy sector, onshore & Offshore wind and Solar PV. Currently Country Manager of EDP Renewables Poland (since 4T 2018), previously working in Energy sector in Portugal, UK, Spain and France. Vice-President of the Polish-Portuguese Chamber of Commerce (PPCC).



Christian Schnell – Solivan Pontes the CEE lawyers

Christian Schnell is a legal counsel admitted at the Regional Chamber of Legal Advisors in Warsaw and Rechtsanwalt (German advocate), admitted at Landgericht Düsseldorf. He also has been awarded a PhD in 2000. He is a lecturer at the Warsaw School of Economics and since a decade regularly consulted by the Polish government and leading employers' associations concerning energy regulatory questions.



Piotr Czopek - PSEW

Director of the Renewable Energy Department in the Ministry of Energy, and subsequently in the Ministry of State Assets and the Ministry of Climate and Environment, responsible for planning of the development of renewable energy sources and building legal framework for its further development. Since January 2021, as Director in the Polish Wind Energy Association has been dealing with regulatory issues related to the promotion of wind energy development in Poland.



Mateusz Przygodzki - GARRIGUES Polska

Legal advisor, in GARRIGUES Polska, responsible for the Banking & Finance practice. He has advised numerous Polish and foreign financial institutions and clients from the energy sector on adjusting their activities to new regulations, restructuring and refinancing, and assisted them in negotiations with financial entities and investors. As an expert participated in the Parliamentary works implementing EU regulations on the Polish market.



Rafał Hajduk - DZP

Head of the energy advisory team. He handles all types of projects in the energy sector and advises on, e.g. investments in energy infrastructure, particularly power plants, project finance, mergers and acquisitions, joint ventures, and trading in energy, fuels, greenhouse gas emission allowances and related derivatives. He is the official Polish legal counsel to EFET (European Federation of Energy Traders). Co-author of Guidance Notes specifically developed for the Polish PPA market for the EFET CPPA standard translated into Polish (February 2020).
