Requirement:

The contractor shall provide on-site and off-site support to the HRDS Programme in three main areas: Lot A - Business Support Services; Lot B - Technical Support Services and Lot C: Data Security Support Services.

The HRDS systems to be supported include: the Automated Personnel Management System (APMS) based on Allocate Software's Allocate Defence Suite (ADS); the Establishment Review Tool (ERT), a bespoke system based on Python code; the ACO/ACT & Missions Identification System (AMIS), based upon Creative Information Technology Inc's manageID Suite; the NATO system for Tracking Entitlements and Privileges (NSTEP); the NATO Performance Management System (NPMS); the Integrated Security and in-processing System (ISIPS), a bespoke system based upon VB6 and .NET technologies; the NATO Installation Access Control System (NIACS). Services shall include development and maintenance of several key components of the HRDS systems including Microsoft SQL database objects; SQL Reporting Services Reports; .NET-based code and workflows; SHAREPOINT 2013 version and above; and

MS Office Visual Basic for Applications (VBA). Contractor's proposed personnel shall be in possession, as a minimum, of NATO

SECRET security clearance.

base period (1 February - 31 December 2020) with possibility to exercise up to four oneyear options. Bidders will be also asked to provide a quotation based on a period of performance of one base (1 February 2020 - 31 December 2022) with possibility to exercise one 2-years option (1 January 2023 - 31 December 2024).

Two sealed envelopes (technical/financial), Best Value. The competitive process will be conducted on the ACO electronic bidding portal (www.ebidexchange.com.aco). Firms interested to participate into this competition shall apply for registration on the portal to become an approved vendor.
