

***Notification of Intent to Invite Competition in accordance with NATO National Competitive Bids Plus (NCB+) Procedure***

**RESTORATION OF OFFICE AND TRAINING FACILITIES FOR JOINT WARFARE CENTRE, STAVANGER NORWAY – NATO PROJECT SERIAL NUMBER 9T111108-0**

1. Background

Norwegian Defence Estates Agency (NDEA) - on behalf of MOD Norway - intends to run a competition for the restoration of the training facilities at the NATO Joint Warfare Centre (JWC) located in Stavanger, Norway. The competition is announced in agreement with the rules and procedures for National Competitive Bidding Plus (NCB+) as defined for the NATO Security Investment Programme. The contract to be established is of a Civil Works nature. With this notification document, NDEA would like to ensure that eligible firms from any NATO member nation are informed and invited to participate in the competition.

2. Scope

The scope of the project covers restoration of an existing facility which will be used by JWC as office and conference facility with a total size approximately 11 000 m<sup>2</sup>. The works will cover restoration of four interconnected building constructions. Most technical equipment and facilities within these buildings will be restored by replacement and the prospective contract will cover most disciplines related to civil works projects.

The value of the contract is estimated to 13 – 15 million Euro exclusive of VAT.

Interested firms will be subject to a pre-qualification process and only those firms, which are pre-qualified, will receive the invitation for tender documents and are qualified to submit a bid.

3. Security.

The main invitation to tender documents to be issued to pre-qualified firms will be unclassified. However, drawings of the facility are classified NATO RESTRICTED, and bidding firms will only be given access to these drawings by visiting NDEA's facility in Stavanger, Norway. The invitation to tender document will be written in the Norwegian language.

All contractor personnel, who will require access to the construction site, must have a valid NATO Security clearance of NATO SECRET.

4. Time schedule

Firms interested in participating in the pre-qualification for this project must show to show interest via the Tenders Electronic Daily (TED) database ([ted.eu](http://ted.eu)) on Internet no later than 2 March 2020 at 12:00 Central European Time. The announcement on TED has the following reference: 2020/S 013-027258 and is also enclosed this document.

The plan is to sign a contract by summer 2020, start works on-site in Stavanger in January 2021 and complete the project by December 2022.

between 4 buildings and 3 floors. 3 of the buildings shall be demolished internally and renovated. All technical installations must be replaced. The fourth building must be reconstructed, and all technical installations must be replaced. All works are internal.

The contractual works for buildings and technical disciplines are approximately equal. The project must be executed as a general contract (NS 8405). The contractual work has been subject to detailed engineering design by Rambøll.

The building works include demolition of walls, roofs, floors, technical equipment, cables, the establishment of a new lift and stairs, rebuilding of walls, floors and ceilings. The technical installation works include: Installation of 3-4 new ventilation systems + ducts, new toilets, kitchenettes, replacement of cooling systems/heating systems, installation of UPS back-up, arrangement of all power, fibre, and telecommunication cables for new systems, installation of a new fire alarm system.
