REGULATION OF THE NATIONAL BROADCASTING COUNCIL

of 12 July 2011

amending the Regulation concerning the classification of programmes or other broadcasts that might have an adverse impact upon a healthy physical, mental or moral development of minors and programmes or other broadcasts intended for a given age group of minors, use of graphic symbols and forms of announcements.

Pursuant to Article 18 paragraph 6 of the Broadcasting Act of 29 December 1992 (official journal "Dz.U." of 2011, No. 43, item 226, No. 85, item 459, No. 112, item 654 and No. 153, item 903), the following is hereby ordered:

§ 1

The Regulation of the National Broadcasting Council of 23 June 2005 concerning the classification of programmes or other broadcasts that might have an adverse impact upon a healthy physical, mental or moral development of minors and programmes or other broadcasts intended for a given age group of minors, use of graphic symbols and forms of announcements (official journal "Dz.U." No. 130, item 1089) shall be amended as follows:

- 1) Appendix No. 1 to the Regulation shall be replaced with Appendix No. 1 to this Regulation;
- 2) Appendix No. 2 to the Regulation shall be replaced with Appendix No. 2 to this Regulation.

§ 2

This Regulation shall take effect after 30 days of its promulgation.
