1. SELECTION OF CO-OPERATION PROJECTS

1.1 Selected co-operation projects for the period 1st May 2017 - 30th April 2019:

The Delegations agreed upon funding mobility costs of 15 co-operation projects with duration from 1st May 2017 - 30th April 2019. (ANNEX 1)

1.2 Ongoing co-operation projects 1st May 2016 - 30th April 2018:

The Polish-Austrian Working Group for Scientific and Technological Co-operation agreed in 2016 upon funding mobility costs of 14 bilateral co-operation projects with the duration from 1st May 2016 - 30th April 2018. All of them will be continued.

Hence mobility costs of a total of 29 bilateral co-operation projects in the field of science and research are jointly funded in 2017.

2.3 Next Meeting for the Selection of Bilateral Co-operation Projects for the Period 2018 – 2020:


The next Meeting for the Selection of Bilateral Co-operation Projects for the Period 2017 – 2019 will be held in Vienna in early 2018.
