SUBJECT: Common SACT HQ Fuel Supply Chain and NSPA Commercial Fuel Support Day.

Dear Ladies and Gentlemen,

I am pleased to announce that NSPA will be organizing a common event regarding fuel supply on **9th of October 2024** at the **NSPA premises in Capellen, Luxembourg**.

As a result of the war in Ukraine, NATO reinforced its force posture in the eastern Europe. Fuel services and related capabilities are key enablers to deploy, reinforce and sustain the large multinational forces.

Supreme Allied Command Transformation (SACT) HQ is developing a Fuel Supply Chain Capability Program Plan (FSC CPP) common funded by NATO to improve fuel supply for NATO troops deployed to protect NATO countries territory. In parallel, NSPA is developing new commercial Fuel capabilities in support of its customers. In view of these new challenges and the resulting NATO logistics policy, NSPA is willing to host industry and NATO Fuel Logistics experts to facilitate an exchange on future opportunities.

An aim of this event is to provide information on fuel business opportunities with both FSC CPP and NSPA as well as to identify commercial service providers to adapt existing NSPA Fuel contracts to the new challenges and to address capability shortfalls. It will be also an opportunity to support the registration of additional companies in the NSPA source file, as well as help companies in their daily use of the NSPA e-Procurement Portal.

These insightful talks will be complemented by interactive committee sessions, providing an arena for constructive dialogue and collaborative problems-solving.

We are aiming at hosting companies capable of:

- acquiring bulk ground and air fuel, including Sustainable Aviation Fuel as well as tactical fuel handling equipment;

- storing fuel in both fixed and deployable capabilities;
- transporting fuel by road, rail or waterways;
- distribution of fuel at tactical level;
- as well as integrators able to deliver those solutions in NATO member's territory.

The focus of this event is on identifying strong regional players who can support operations during peace, crisis and war in the Baltic States, Sweden, Finland, Poland, Slovakia, Czechia, Romania, Bulgaria, Greece and Türkiye.

This event offers an invaluable platform for fostering deeper relationships and enhancing collective understanding of the intricate challenges and opportunities inherent to operating Fuel supply. By engaging in discussions, sharing insights, and proposing ideas, we can pave the way for future collaborations that hold immense potential.

The tentative agenda at annex 1 will provide generic SACT and NSPA presentations to attending companies, together with workshops dedicated to specific topics and have access to NSPA Source File registration for the companies not registered so far.

The final agenda and administrative details will be released shortly thereafter to the interested companies within the targeted industry.
