**REGULATIONS**  
**for completing Russian permits and special single permits for International Road Haulage from or to the third state territory**

1. A foreign carrier engaged in the International Road Haulage of goods shall be responsible for completing the following items of the Russian permit approval documents before the vehicle owned by the carrier passes through the territory of the Russian Federation:

a) name of the foreign carrier and its address specifying the locality, the street, the building - item 4 of the Russian permit approval document (annexes No. 4-6 hereto);

b) vehicle registration number - item 5 of the Russian single permit approval document (annexes No. 4, 5 hereto) (hereinafter referred to as a single permit), item 7 of the Russian multiple permit approval document (Appendix No. 6 hereto) (hereinafter referred to as a multiple permit);

c) place, date of issue, signature and stamp of the foreign state authorized body that issued the permit - item 8 of single permit document, item 8 of multiple permit document;

d) date and place of entrance into the territory of the Russian Federation - item 9 of single permit document. When travelling in transit through the territory of the Russian Federation, the information relating to the first entry into the territory of the Russian Federation shall be specified;

e) if a vehicle containing cargo passes through the territory of the Russian Federation:

name of the cargo transported - item 10 of single permit document;

weight of cargo transported - item 11 of single permit;

state and/or loading point - item 12 of single permit document; state and/or offloading point - item 13 of single permit document<sup>1</sup>.

When transporting goods from several shippers, in items 10, 12, 13 of single permit document the data shall be indicated relating to the consignment that was shipped first. The weight of each consignment transported shall be indicated in item 11 of single permit document;

f) if an unladen vehicle passes through the territory of the Russian Federation:

name of travel commencing state - item 12 of single permit document;

name of travel completion state - item 13 of single permit document;

2. Foreign carrier engaged in the occasional passenger International Road Haulage

shall be responsible for completing the following items of the Russian permit approval documents before the vehicle owned by the carrier passes through the territory of the Russian Federation:

a) name of the foreign carrier and its address - item 5 of the Russian single permit approval document (Appendix No. 7 hereto) (hereinafter referred to as the passenger permit);

b) bus brand - item 6 of passenger permit document;

c) state and/or destination point - item 7 of passenger permit document;

d) bus registration number- item 8 of passenger permit document;

e) the number of passengers in forward and backward direction - item 9 of passenger permit document;

f) place, date of issue, signature and stamp of the authorized foreign authority that issued the passenger permit - item 11 of passenger permit document.

3. The foreign carrier shall provide clarifying information about the state and/or loading point and about the state and/or offloading point in items 12, 13 of single permit upon the commencement of the vehicle shipping in the following cases:

a) entry of an unladen vehicle into the territory of the Russian Federation that previously performed a transit transport through the territory of the Russian Federation according to the Russian single permit, for shipping in the territory of the Russian Federation and performing subsequent two-way transport according to the same single permit, if it is permitted by the type of permit;

b) passing of an unladen vehicle, previously unloaded in the territory of the Russian Federation to the place of shipment.

4. The foreign carrier shall fill in the items of the Russian single permit for International Road Haulage from or to the third state territory in accordance with the type of International Road Haulage and the terms of its use in accordance with clause 3, Article 2 of the Federal Law No. 127-FL "Concerning State Control Over International Road Haulage and Concerning Liability for Violation of the Procedures Governing Such Haulage" dd. July 24, 1998.

5. In case if the International Road Haulage according to a single permit starts in the territory of the Russian Federation, the foreign carrier shall be responsible for completing single permit document upon the commencement of the vehicle shipping. At the same time, the date and place of entrance into the territory of the Russian Federation preceding the commencement of transport according to single permit shall be specified in item 9 of single permit document.

6. In case of non-completing or incorrect completing the items of the Russian permit document, or if there are no notes about the entrance of the vehicle into the territory of the Russian Federation or its departure from the territory of the Russian, the permit shall be deemed invalid.

Corrections of information in single permit and multiple permit documents to be entered by the carrier (name and address of the carrier) are allowed if they are certified by the foreign state authorized body that issued these permits for the carrier, provided that such corrections are agreed with the competent authority responsible for transport of the relevant foreign state through the negotiations on international road service issues and reflected in the minutes of negotiations. The information related to the vehicle

registration number can be amended by the carrier or by the vehicle driver and certified by the carrier's seal (if available) in case of replacement of the vehicle which is out of operation that must be confirmed by vehicle technical construction file issued by agencies carrying out vehicle maintenance.

In the event that the above documents are issued by the competent authorities or agencies carrying out the maintenance of foreign state vehicles, their translation into Russian shall be certified according to the procedure established by the legislation of the Russian Federation.

Any other corrections to the permit document are not allowed.

The carriers of member states of the Eurasian Economic Union are allowed to use permit without a mark of entry of a vehicle into the territory of the Russian Federation only provided that the transport starts from the territory of the Russian Federation when transporting goods into the third state territory.

7. In the event that the provisions of the Procedure for Transport (Car) Control at the External Border of the Eurasian Economic Union are applied in respect of the International Road Haulage (Appendix No. 1 to the Minutes of Coordinated (Harmonized) Transport Policy ((Appendix No. 24 to the Contract about Eurasian Economic Union)<sup>2</sup>, the foreign carrier shall be responsible for completing single and multiple permit document prior to vehicle entrance into the territory of the Russian Federation.
