#### REPORT TO THE BORDER GUARD

- if you enter the territory of Poland during a border control, tell the Border Guard you want to submit an application for international protection;
- if you are staying within the territory of Poland, go to any of the branches or offices of the Border Guards, and state that you want to submit an application for international protection;
- if you are in detention or in prison in Poland, send the information to the Border Guard that you are a prisoner and that you want to submit an application for granting international protection (ask the detention or the prison you were placed in to send the letter).

#### IF:

If the Border Guards is unable to receive the application on the day of your visit, you will be informed on the date and place of accepting the application in a language understandable for you.

If you want for the application to also cover your husband/wife and children, they also have to come with you to the Border Guards.

**NOTE! The application which you fill in an send on your own to the Border Guards or to the Head of the Office for Foreigners will not be examined!**



During submission of the application:

- your photographs will be taken;
- your fingerprints will be taken (persons who are older than 14 years);
- you will be examined by a doctor.



The Border Guard will fill the application form with the information you give him/her.

If necessary the interpreter speaking your language will also be present.



When submitting the application, show all the documents you have, in particular a passport.



Acceptance of the application starts the procedure for granting you international protection. As confirmation you will receive a document - a Temporary Foreigner's ID - PL: "Tymczasowe Zaświadczenie Tożsamości Cudzoziemca" (TZTC), which, when valid, confirms your identity and gives you the right to stay within the territory of Poland. You will be informed orally and in writing about the rules and the course of proceedings in the case for granting international protection and on your rights and obligations related with submission of the application, as well as on the social, legal assistance and medical help you are entitled to.
