Informacje ogólne

Informacje te opierają się na informacjach dostępnych dla misji dyplomatycznych w momencie pisania. Informacje, a w szczególności wyznaczenie prawników i innych asystentów prawnych są niewiążące i bez gwarancji. Lista nie jest wyczerpująca. Lista jest uporządkowana alfabetycznie i nie ma innego znaczenia. Informacje o kancelariach prawnych, ich specjalnościach i językach korespondencyjnych są dostarczane przez samych prawników. Placówka nie gwarantuje poprawności zawartych danych. Wybierając kancelarię prawną, klient musi uiścić wszystkie koszty i opłaty z tym związane.

- W Chińskiej Republice Ludowej prawnicy są przyjmowani do wszystkich sądów - od zwykłego Sądu Ludowego po Najwyższy Sąd Ludowy; nie ma ograniczeń. Zagraniczne firmy prawnicze nie mogą reprezentować przed chińskimi sądami powszechnymi (ale nie przed sądami arbitrażowymi).
- W niektórych przypadkach istnieje obowiązek prawnika i notariusza. Są one regulowane przez prawo. Na przykład przed emisją akcji adwokat musi przygotować opinię na temat spółki i jej działania oraz przedłożyć ją właściwym organom (w tych przypadkach China Securities Regulatory Commission).
- Oskarżeni mają prawo do wyznaczenia obrońcy na każdym etapie procesu karnego. Jeśli oskarżony nie ma adwokata, sąd może wskazać obrońcę. W takich przypadkach oskarżony ma również prawo do odrzucenia obrońcy. Sąd może wyznaczyć innego obrońcę lub sam pozwany może wyznaczyć adwokata.
- W Chińskiej Republice Ludowej istnieją lokalne systemy opłat dla prawników, zgodnie z którymi doradztwo może być opłacane za godzinę lub według wartości spornej/podstawy sukcesu. W przypadku zlecenia naliczane są „opłaty za usługi prawne”, które różnią się w zależności od kancelarii prawnej. Przybliżony szacunek poniesionych kosztów jest możliwy przed zawarciem umowy.
- Osoby w trudnej sytuacji ekonomicznej mogą ubiegać się o pomoc prawną w Centrum Pomocy Prawnej, które jest wspierane finansowo przez Ministerstwo Sprawiedliwości i Rządu Prowincji. Jeśli wniosek zostanie zatwierdzony, adwokat zostanie wybrany przez Centrum Wsparcia Prawnego z puli prawników.
