As the only Europe-wide award scheme for public sector bodies, EPSA provides a unique opportunity for administrations to showcase their achievements in public sector innovation and reform. Since 2009, when EPSA was organised for the first time by the European Institute of Public Administration (EIPA), more than 1,500 innovative projects have been submitted, demonstrating the agility of the public sector to reform, adapt and to continue delivering services efficiently and effectively to citizens across Europe. Over time, EPSA has developed into a platform of public sector innovation, having generated highly valuable know-how and vital results that can be used for the benefit of providing practical solutions and learning opportunities. The new EPSA 2023-24 edition, once again, invites innovators and change agents at all levels of government to join the EPSA community and submit projects in three award categories.

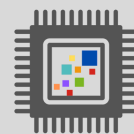

ELIGIBILITY & EVALUATION

Public sector entities across Europe from all levels of government, including public sector enterprises and agencies are eligible to submit projects by filling in the online application form. Projects can be submitted jointly by more than one organisation, including cross-country applications and private or mixed-capital entities, not-for-profit/third sector organisations or academic institutions. Previous EPSA participants may re-submit projects submitted to earlier editions insofar as they are based on a material adaptation, update and/or extension of past projects, including the achievement of significant further results since any previous submission.

All submitted projects are evaluated based on a well-established methodology, which includes several stages, and which is committed to the highest level of quality, transparency and integrity. The criteria for evaluating projects have enduring relevance and are applicable to innovation and reform addressing all dimensions of public administration.
