

Notification of Intent to Invite National Competitive Bids Plus (NCB+)

RESTORATION AND UPGRADE OF FUEL FACILITY AT EVENES AIRBASE, NORWAY

1. Background

Norwegian Defence Estates Agency (NDEA) - on behalf of MOD Norway - intends to issue an invitation to submit tender under the rules and procedures for National Competitive Bidding Plus (NCB+) as defined for the NATO Security Investment Programme. The project will cover restoration and upgrade of fuel tanks at Evenes Airbase. Evenes is located in Northern Norway south of the city Harstad.

With this notification document, NDEA would like to ensure that eligible firms from any NATO member nation are informed and invited to participate in the competition.

2. Scope

The scope of the project is restoration and reconstruction of an existing fuel facility. The procurement is divided into 2 separate contracts. Contractors can enter into one or both competitions.

Competition 3:

The contract to be established will include the following:

- Comprehensive work on pipes in carbon steel and stainless steel.
- Restoration of systems for ventilation and dehumidification
- Delivery of both prefabricated and purpose-built steel tanks in different sizes

Estimated value of the contract is between 2.9 mill Euro and 3.6 mill Euro exclusive of VAT.

Competition 4:

The contract to be established will include the following:

- Work on electrical panels in technical room involving various Guidance/Control systems
- Constructions of conduits and ducts for cables
- Works on existing processing equipment

Estimated value of the contract is between 1.2 mill Euro and 1.7 mill Euro exclusive of VAT.

Special qualification requirements for Competition 4:

Contractors that perform work on electrical systems in Norway must be in possession of the required national certification for such works in order to assure that works are in compliance with

Norwegian rules and regulations for work electrical systems. Reference is in this respect made to the following information which may be found on the Internet:

The two contracts are scheduled to be signed during autumn of 2019 and start of works at site shortly after contract signature.

The project has been prefinanced in accordance with NATO rules and procedures.

3. Security.

All contractor personnel, which will require access to the construction site, must have a valid NATO Security clearance of NATO CONFIDENTIAL or above.

The bid document to be issued to interested firms will have a maximum security classification equivalent to NATO CONFIDENTIAL and it will be written in the Norwegian language.

4. Time schedule

Contractors interested in participating in the bidding are requested to show interest via the Tenders Electronic Daily (TED) database (ted.eu) on Internet no later than 5 August 2019. The announcement on TED has the following reference: 2019/S113-278757.
