**NOTICE OF INTENTION TO ISSUE AN INVITATION FOR INTERNATIONAL BIDDING
(IFIB)**

1. In support of the activities of the NATO Headquarters C3 Staff (NHQC3S), the Financial Controller, IMS intends to invite bids for the maintenance of an application called "Spectrum Management Information Repository On Line (SMIR-On-Line)". This application is used by the Spectrum Management community to exchange radio spectrum management data for the day-to-day military exercises and operations.

2. Title of the IFIB: NHQC3S SMIR-On-Line Maintenance

3. Requirements: NHQC3S requires contractors' support for the maintenance of SMIR-On-Line. SMIR-On-Line is a web application developed using the Microsoft.Net 4.7.x and ASP.Net Core frameworks in C# and Javascript/JQuery, hosted on Windows 2012 servers with the Internet Information Services (IIS) and using SQL Server as the backend database system. Version 2 of the application has been partially developed by a contractor and needs finalizing and testing. Once accepted and deployed, upgrades as requested by users will be scheduled and ordered as individual purchase orders within the maintenance contract.

5. Period of performance: Maintenance period up to 3 years

6. Bidding Procedure: Sealed Bidding, Two-Envelope method.


