Extension of legal stay

Period of your legal stay based on:

- national visa
- temporary residence permit

will be extended until the end of the 30th day following the date of cancellation of the state of epidemic emergency or state of epidemic - **do you have to complete any formalities?**

No, your legal stay will be extended by law. This will not involve placing a new visa sticker on your travel document or issuing a new residence card.

Extension of legal stay

On March 14, 2020, you stayed in Poland based on:

- visa-free travel
 - Schengen visa
 - visa (including a long-stay visa), residence document issued by another country of the Schengen area
 - long-term visa, residence permit issued by another Member State of the EU that is not a Schengen state, if, in accordance with the provisions of the EU law, it entitles to stay on the Polish territory
- and **your legal stay ends** within the period of state of epidemic emergency or state of epidemic?

Your stay will be considered legal by law until the end of the 30th day following the date of cancellation of the last of the above-mentioned states that was in force. .


Extension of legal stay

Your stay based on:

- visa-free travel
- Schengen visa
- visa (including a long-stay visa), residence document issued by another country of the Schengen area
- long-term visa, residence permit issued by another Member State of the EU that is not a Schengen state, if, in accordance with the provisions of the EU law, it entitles to stay on the Polish territory

will be considered legal until the end of the 30th day following the date of cancellation of the state of epidemic emergency or state of epidemic - **do you have to complete any formalities?**

No, your legal stay will be extended by law. It will not require submitting any applications or issuing permits or documents.


Stay

You stay in Poland based on:

- permanent residence permit or long-term EU resident permit
- refugee status or subsidiary protection
- permit for tolerated stay or for humanitarian reasons

and the period of validity of your residence card (or the "permit for tolerated stay") ends during the state of epidemic emergency or state of epidemic?

?



Your stay will still be legal because these **permits are of an indefinite nature.**

The period of validity of residence cards will be extended until the end of the 30th day following the date of cancellation of the last of states that was in force.


Extension of validity of residence cards and TZTC

The expiry date of your:

- residence card
- temporary certificate of identity (TZTC)

ends during the state of epidemic emergency or state of epidemic?

The period of validity of these documents will be extended until the end of the 30th day following the date of cancellation of the last of states that was in force.

Extension of deadlines for submitting applications

You would like to apply for:

- extension of a national visa (symbol D) or a Schengen visa (symbol C)
- granting a temporary, permanent or long-term EU resident permit
- extension of stay on the basis of visa-less travel (applies only to citizens of Brazil, Argentina, Chile, Honduras, Costa Rica, Nicaragua, Singapore and Uruguay)?

The period for submitting these applications will be extended if the deadline falls during the state of epidemic emergency or the state of epidemic. Applications may be submitted to voivodship offices up to the 30th day following the date of cancellation of the last of the above-mentioned states that was in force.

Stay

You are a citizen of a Member State of the European Union, the European Free Trade Agreement (EFTA) or the Swiss Confederation.

Does the introduction of the state of epidemic **affect your residence rights in Poland?**

No, the introduction of the state of epidemic emergency in Poland, followed by the state of epidemic, does not affect your residence rights or the rights of your family members staying with you.
