Important publications: Union with God in Padre Pio's (Francesco Forgione) life and works, Kraków 2000; Fundamental role of faith in life and works of Saint Teresa Benedicta of the Cross (Edith Stein), Kraków 2005; "what should I do to inherit eternal life?". Christian spirituality in the lay way of life, Kraków 2008; Priesthood in the teaching of the pope John Paul II, Kraków 2010, Spirituality according to Edith Stein, Kraków 2018.



Rev. Prof. Associate. Michał Drożdż - Associate Professor, Master of Theology, Master and Doctor of Philosophy of Science, postdoctoral degree in social sciences in the field of media sciences, dean of the Faculty of Social Sciences of the Pontifical University of John Paul II in Cracow, co-founder and the first Director of the Institute of Journalism and Social Communication of the University, Head of the Department of Media and Social Communication, Director of the Academic Media Center, Editor-in-chief of Socialia Cracoviensia Studio; author of over a hundred articles and over a dozen books in the field of media philosophy, media theory, media ethics, and philosophy of science; member of the Board of the Polish Society for Communication, Social and Chairman of the „Axiology of

Communication" section of PTKS, member of Polish and foreign scientific societies; member of the Scientific Excellence Council for the 2019-2024 term.

Main research interests include: media ethics, media axiology, ethics and axiology of social communication, philosophy and methodology of science, science ethics, science and project management, as well as nature philosophy and cosmology.



Jarosław Boguszyński - Director of the Analysis and Migration Policy Department of the Ministry the Interior and Administration, member of the European Migration Network Steering Board since October 2019. He is responsible for Polish migration policy, migration research and counteracting trafficking in human beings.
