Each participant chooses a program from the following four repertoire ranges according to his level of proficiency (without division into age groups).

Program should be performed from memory.

The International Jury will evaluate the participants' performances on a scale from 1 to 25 pts, taking into consideration: artistic merit, sound aesthetics, stylistic compatibility, technical skills, as well as performance quality of the selected Repertoire.

- ✓ For every Repertoire, the Jury will choose the 1st, 2nd and 3rd place Prize-Winners, and will announce honourable mentions.
- √ The Prize-Winners shall be awarded at least 21 points; the honourable mentioned at least 20 points.
- √ The Jury chooses any number of honourable mentions.
- √ The Jury reserves the right not to select Prize-Winners or to announce ex-aequo awards.
- √ The Jury's decisions shall be final and irrevocable.

The winners of the Festival receive the entitlements referred to in:

- (a) Article 44zh of the Law of September 7, 1991 on the educational system (exemption from the promotional examination at the art school with the highest positive annual classification grade),
- (b) Article 132 of the Law of December 14, 2016. Education Law (priority admission to secondary schools),
- (c) or regulations issued pursuant to Article 162 of the Law of December 14, 2016. Education Law (the manner of converting individual criteria into points during the recruitment procedure to secondary schools).
 - 1. This year's Festival is financed by the Centre for Artistic Education.
 - 2. For participants from Poland, participation in the Festival is free of charge.
 - 3. Foreign participants are required to pay an entry fee of 50 Euros to the following bank account:

- 4. Qualification of participants to the Festival is determined by the order of applications.
- 5. Applications of participants for the XXXII International Chopin Festival in Mazovia will be accepted through an electronic online form made available from October 21 to November 8, 2024.

The form must be accompanied by a scan of signed consents for the processing of personal data and permission to disseminate the image (the statement is attached as Appendix 1 to these regulations, or downloadable at:

NOTE: failure to attach the above documents will result in inability to participate in in this Festival.

Deadline for submission of applications - until 08.11.2024.

- 1. All Festival Participants will receive Diplomas.
- 2. The Prize-Winners will additionally receive Honourable Diplomas and material Awards.
- 3. The repertoire of the Concert of Prize-Winners will be determined by the Jury.
- 4. Participation in the Concert of Prize-Winners and in the concerts organized in Żelazowa Wola is obligatory.
- 5. The Festival Participants along with their Pedagogues will have the possibility to consult the Festival Jury (please have your sheet music). The term of the Jurors consultations will be announced with additional schedule.
- 6. The Jury will select the Prize-Winners having listened to the performances of all four repertoires.
- 7. The list of participants qualified to participate in Public Performances, as well as the approximate performance schedule will be available on the following website:

- 8. The rehearsals of the participants ought to be arranged by phone with the organizers: +48 46 862 29 62.
- 9. All participants should be at the Jury's disposal one hour before their performance.
- 10. The participants' performances and the Concert of Prize-Winners may be streamed free of charge, and photographed for press purposes to promote the Festival.
